ARTICLE 13, EU REGULATION 2016/679 ('GDPR')

- **WHAT PERSONAL DATA WE COLLECT:** for the purposes indicated in this statement, we collect common personal data (eg name, surname, address, telephone numbers and e-mail). This personal data is only that which has been freely shared by external parties;
 - **PURPOSE AND LEGAL BASIS:** the data will be collected exclusively to carry out the activities deriving from the existing relationships between the parties as well as any further services expressly requested. This data will be kept at our registered office, and its protection is the responsibility of the owner and any designated managers. Retention of this information is lawful because it is based on the express consent expressed by the interested party as documented in writing or as specifically requested by the interested party, for example following a request via e-mail. The consent of the interested party is essential for these purposes;
 - **RETENTION METHODS:** the data supplied by you will be filed either physically or on computers. This will be structured under the strict logic of the purposes of the association or relationship. It will also be guarded and treated with in strict confidence as envisaged under the current law;
 - **NATURE OF THE AGREEMENT AND THE CONSEQUENCE OF REFUSING TO CONFIRM PERSONAL DATA:** the sharing of relevant personal data is a necessary requirement for participation in the association and any failure to provide the requested data will make it impossible for us to fulfil our obligations;
 - **COMMUNICATION OF PERSONAL DATA:** all data collected and retained can and will only be communicated, in Italy and abroad, exclusively for the purposes specified above. Sharing would only be to companies / professional firms that provide assistance and administration, tax, financial or labour advice, or to public administrations for the performance of institutional functions within the limits established by law or regulations;
 - **DURATION OF RETENTION:** the data will be kept for the entire duration of any agreed association and, subsequently, as provided for by law and by fiscal legislation, with suitable procedures to guarantee confidentiality, for 10 years from the end of any such relationship;
 - **YOUR RIGHTS:** In relation to your own data covered by this statement, you can exercise the rights set out in articles 15 to 21 of the GDPR. In particular, you have the following rights:
 - right of access - Article 15 of the GDPR affirms the right to obtain confirmation that your personal data is being retained and to get access to your personal data and receive a copy thereof;
 - right of rectification - art. 16 GDPR affirms the right to obtain correction of all inaccurate data concerning you and / or adding to incomplete personal data, without undue delay;
 - right to cancellation (right to be forgotten) - art. 17 GDPR affirms your right, without undue delay, to the erasure of your personal data in accordance with the terms indicated in EU Regulation 679/2016;
 - right to limit data retention - art. 18 GDPR affirms your right to limit data retention when:
 - the interested party disputes the accuracy of personal data;
 - retention is illegal and there is opposition to the erasure of personal data asking instead that its use is limited;
 - although the Data Retainer no longer needs it for processing purposes, personal data are deemed necessary for the assessment, exercise or defence of a right in court;the interested party has opposed retention, as indicated above, pending verification of any possible legitimate reason of the Data Controller with respect to the data of the interested party;
 - right to data portability - art. 20 GDPR affirms the right to receive personal data concerning you provided to the Owner and the right to transmit them to another Owner without impediment, if the treatment is based on consent and is done by automated means. Furthermore, the right for your personal data to be transmitted directly by the Data Controller to another Data Controller if this is technically feasible;
 - right of opposition - art. 21 GDPR affirms the right to object, at any time to processing personal data concerning the legitimacy of legitimate interest, including profiling, unless there are legitimate reasons for the holder to continue the treatment that prevail over the interests, rights and on the liberties of the interested party or for the acquisition, exercise or defence of a right in court;
 - revocation of consent previously given;
